**Subject: Stop Nuclear Proliferation, Stop Nuking Asia Our Homeland, Stop Putting up  
the Level of Background Radiation for the World**

We, Asian people concerned about health, and ecological and genetic threats posed by nuclear proliferation in military and civilian realms, are most disappointed by your government's continuous active engagement in nuclear business after the Fukushima nuclear disaster and numerous testimonies to nuclear harm to humans, future generations, and the ecologies.

The presence of representatives from your country at Nuclear Energy Asia 2011 Conference in Hong Kong (held on December 5-6, 2011, at InterContinental Grand Stanford Hotel) clearly demonstrates the nuclear industry-government-IAEA collaboration to relentlessly pursue self interest at the expense of well-being and sustainability of all lives on earth, by promoting nuclear technologies which will discharge more and more deadly man-made radioactivity into the air, soil, waters and atmosphere and eventually all of the global environment.

We hereby strongly and solemnly demand that your government immediately stop participating in nuking our Asian homeland, and shift to adopt a more responsible position which shows respect to lives on planet earth and to proactively END NUCLEAR PROLIFERATION and ABOLISH ALL NUCLEAR POWER.

For many of those who have deceased or are suffering from sicknesses as a consequence of nuclear radioactivity contamination, it is already too late. Still, it is better late than never. In the words of the well-respected epidemiologist Alice Stewart, "You must on no account put up the level of background radiation.... It is no longer possible to defend nuclear power by saying, 'Well, we're only adding a fraction to background radiation.' You must not add anything!" It is also a matter of consequence that those of you who are running the government start to recognize the gravity of the words of the nuclear physicist and radiation medical doctor John Gofman, "Now that we know that nuclear plants release radioactivity and kill a certain number of people, scientists who support these nuclear plants—knowing the effects of radiation—don't deserve trials for experimentation; they deserve trials for murder."
